THE DAILY CASSEROLE PROGRAM HAS MORE THAN 60 CHURCH GROUPS COMPRISED OF 2,500 VOLUNTEERS PREPARING 125,000 MEALS FOR PEOPLE IN OUR MENTAL HEALTH PROGRAMS. APPROXIMATELY 3,000 CLIENTS WERE DEALING WITH BEHAVIORAL HEALTH ISSUES AND 1,500 RECEIVED BEHAVIORAL HEALTH SERVICES. THE WOMEN'S NIGHT SHELTER SERVED APPROXIMATELY 100 MENTALLY ILL WOMEN. AN ASSERTIVE COMMUNITY TREATMENT TEAM HAS HOUSED 54 CLIENTS LAST YEAR.

APPROXIMATELY 1,200 PEOPLE ARE ASSISTED ANNUALLY IN FINDING PERMANENT EMPLOYMENT. SPECIAL EMPHASIS IS PLACED ON ASSISTING NEARLY 170 VETERANS WITH EMPLOYMENT AND ADVANCED EMPLOYMENT TRAINING. A TOTAL OF 284 PEOPLE WERE PLACED IN FULL-TIME OR PART-TIME JOBS. JOB READINESS CLASSES AND ON-THE-JOB TRAINING ACTIVITIES HELP PREPARE 400 PEOPLE FOR THEIR FUTURE JOBS. MCMURPHY'S CAFE AND EXPRESS LOCATIONS TRAIN APPROXIMATELY 100 PER YEAR FOR FUTURES IN THE RESTAURANT INDUSTRY.

OPERATION INDEPENDENT HOUSING AND HOUSING SUPPORT RESULTED IN 575 PEOPLE BEING PLACED INTO PERMANENT HOUSING. ROSATI APARTMENTS AND GROUP HOME PROVIDED HOUSING TO APPROXIMATELY 75 PEOPLE. 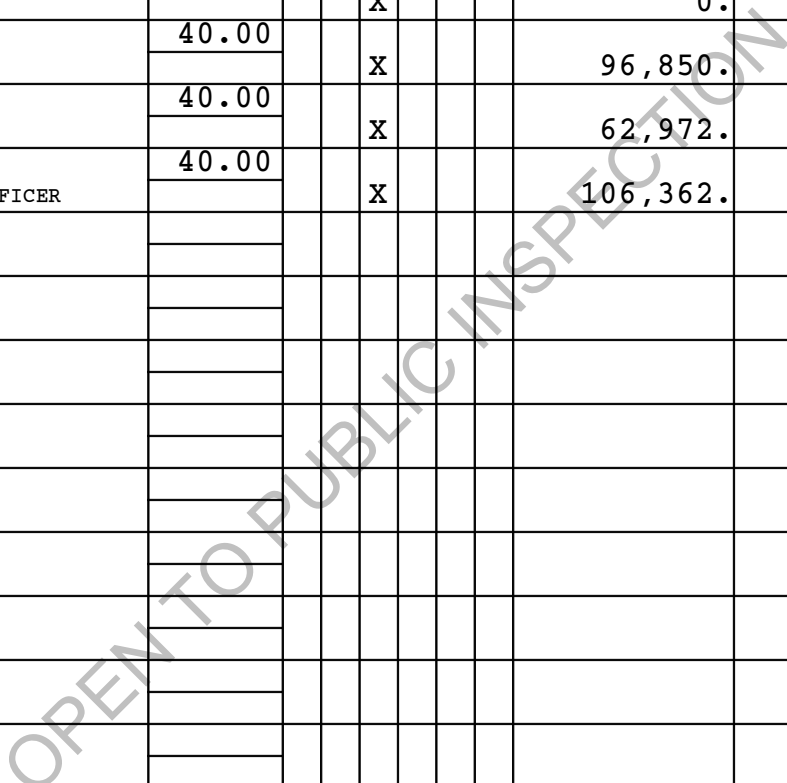

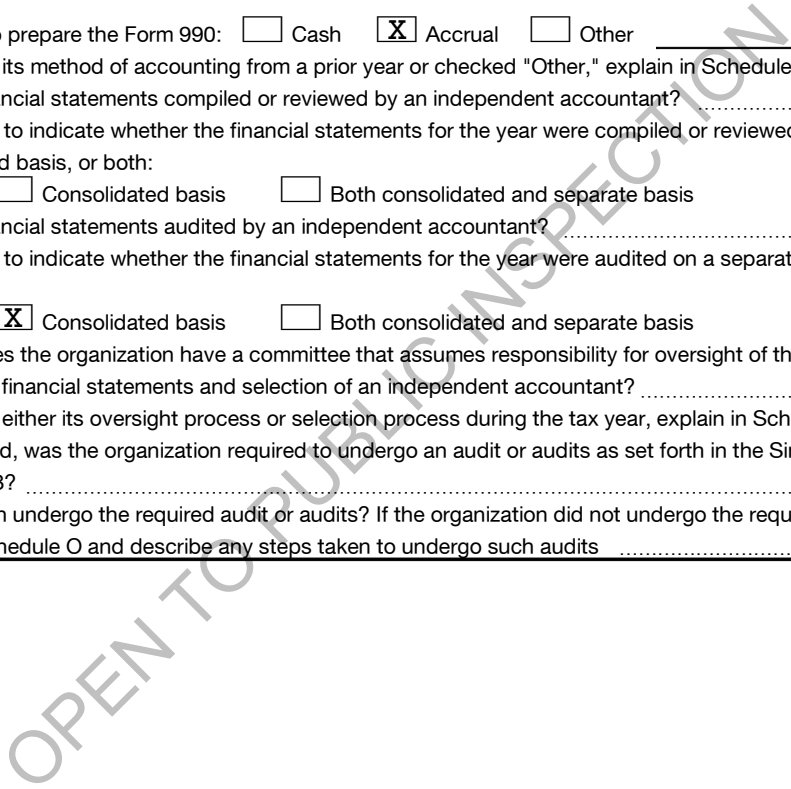
